Food Access at Mariposa Food Co-op

Mariposa Food Co-op is committed to increasing access to nutritious, affordable foods while creating a welcoming space in our community. Our **Food For All program** provides the following benefits for qualifying, low-income member-owners:

- **10% everyday discount.** Recipients may also become working-members for an additional 5% discount.
- **Equity payment assistance** by covering up to \$100 of the \$200 investment. After their first year, recipients begin paying at a lower rate of \$10 every three months until they reach \$100 of personal equity.

WHO CAN APPLY?

- **New member-owners** can apply as a way of joining, at no cost, in the first year and receiving a 10% discount on all purchases.
- **Current member-owners** who have paid their full equity investment can apply to receive a 10% discount on all purchases.
- **Current member-owners** who have partially paid their equity investment can apply to receive assistance covering the remaining portion up to \$100, in addition to a 10% discount on all purchases.

NOT A MEMBER-OWNER YET? JOIN TODAY!

When you join Mariposa Food Co-op, **you become a member-owner** of our food cooperative. This means you have a voice and vote in decisions regarding the Co-op's future, in addition to many other benefits, including:

- **the opportunity to run for the Board of Delegates.**
- **the opportunity to receive patronage refunds during the Co-op's profitable years.**
- **exclusive discounts on select products every month.**
- **discounts at our Community Partners.**
- **an additional 10% discount on products ordered in bulk.**
- **an additional 10% discount during quarterly Owner Discount Days.**

I understand that:

- Food For All (FFA) benefits are valid for one year. I must renew annually.
- if my FFA 10% discount expires, I will not receive a retroactive discount.
- the discount can neither be shared nor applied to gift cards.
- I may receive equity assistance up to \$100 and will not be asked to make additional payments in my first year. If I renew, I will begin making payments of at least \$10 every three months until I reach \$100.
- if I choose to leave Mariposa Food Co-op, the \$100 of equity assistance will be returned to the Owner Fund. Any equity I personally contributed will be fully refunded.
- Mariposa Food Co-op may withhold equity refunds to protect the financial health of the Co-op.
